

Articles of Incorporation

ARTICLES OF INCORPORATION FOR A TAX-EXEMPT NONSTOCK CORPORATION

FIRST: The undersigned **Nuri Delen** whose address is **10648 Hillingdon Road, Woodstock, MD 21163** being at least eighteen years of age, does hereby form a corporation under the laws of the State of Maryland.

SECOND: The name of the corporation is "**The Social Contract Corporation.**"

THIRD: The purposes for which the corporation is formed are as follows: **To provide dynamic community services and to supplement the activities of existing community organizations. The Social Contract Corporation** shall take food products from fresh food stores and supply them to organizations that give services to people in need. Furthermore, **the Social Contract Corporation** shall also assist in the distribution efforts at the partnering organization's venue. **The Social Contract Corporation** shall also supply temporary volunteers for specific events sponsored by other nonprofit organizations that benefit the community.

FOURTH: The street address of the principal office of the corporation in Maryland is **10648 Hillingdon Road, Woodstock, MD 21163.**

FIFTH: The name of the resident agent of the corporation in Maryland is **Nuri Delen** whose address is **10648 Hillingdon Road, Woodstock, MD 21163.**

SIXTH: The corporation has **no authority to issue capital stock.**

SEVENTH: The number of directors of the corporation shall be six which number may be increased or decreased pursuant to the bylaws of the corporation. The names of the directors who shall act until their successors are duly chosen and qualified are **Omar Delen, Alex Zabaldo, Andrew Liu, Karam Singh, Selin Onal, and Akhil Mansabdar.**

EIGHTH: **The Social Contract Corporation** is organized exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Articles of Incorporation

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
